How to plead GUILTY or NO CONTEST and pay fine. (option 2 below) You must appear in person or by CERTIFIED mail.

DO NOT MAIL CASH! If you wish to plea guilty or no contest, please check the appropriate plea below. Date and sign your name.

How to request DRIVING SAFTEY Course (Defensive

<u>Driving</u>). (Option 3 below) If you have a CDL Drivers License or were driving 25 mph over the posted speed limit or in excess of 95 mph YOU CANNOT request defensive driving. You may request to take the Driving safety course as long as you have not taken the class in the last 12 months to dismiss a ticket. A payment of \$120.00 court cost will be due and the fine amount is waived. You will have 90 days to take a defensive driving class and send the certificate of completion to us.
